Act s. 3(1)	<p><b>WHEREAS</b> it has been reported to Manitoba Early Learning and Child Care ("MELCC") that on August 7, 2014, during outdoor play, a 2 ½ year old child left the community park unescorted by any Happiness Is...Inc. ("the Centre") Centre staff.</p> <p>The incident occurred at approximately 10:10 a.m., when a motorist driving by the park witnessed a young child riding a toy car leave the park and proceed out onto Niverville Avenue. The motorist reported sounding their car horn to get the attention of Centre Staff. Centre staff then noticed the child on the street and ran out to retrieve the child and return to the park.</p> <p><b>AND WHEREAS</b>, the licensee fails to meet <i>The Community Child Care Standards Act</i> and Manitoba Regulation 62/86 as hereinafter provided.</p> <p>3(1) Every person providing child care shall at all times provide an environment that is conducive to the health, safety and well-being of the children.</p> <p>And Manitoba Regulation 62/86 (the "Regulation") sections:</p>


