RE: ENVIRONMENT ACT LICENCE NO. 1245

In response to your discussions with Mr. Bernie Chrisp, Regional Director, Park-West Region, Environmental Operations, this letter will confirm that Environment Act Licence No. 1245 is now the responsibility of Triple Leaf Minnedosa Ltd.. The Act does not allow the re-issuance of or change to a Licence without the submission and processing of a new Proposal. Section 15(4) of the Act transfers Licences to "a person who purchases or otherwise acquires custody or control over the development".

THIS LICENCE IS ISSUED TO:


TRIPLE LEAF MINNEDOSA LTD.; Applicant
ALFA MILLS LTD.; APPLICANT

The following limits, terms and conditions shall be complied with in connection with the operation of a cubed alfalfa feed manufacturing plant located at or near 175-1st Avenue, N.W. in the Town of Minnedosa, Manitoba.

1. The Applicant shall not cause or permit the emission of particulate matter from any point of emission of the operation in excess of 0.23 grams per dry standard cubic metre calculated at 25 degrees Celsius and 760 millimetres of mercury, corrected to 12 percent carbon dioxide for processes involving combustion.
2. The Applicant shall not cause or permit visible emissions from any point of emission of the operation that exhibit an opacity equal to or greater than:
 - (a) 20 percent for more than 4 minutes in the aggregate in any one hour;
 - (b) 40 percent at any time.
3. The Applicant shall limit the emission of particulate matter from the operation to such an extent that airborne particulate matter from any part or process of the operation does not exhibit an opacity greater than 5% at any point beyond the property line of the operation.
4. The Applicant shall at all times maintain a high standard of equipment maintenance and good housekeeping practices consistent with meeting the limits, terms and conditions prescribed by this Licence.

5. The Applicant shall undertake an investigation by professionals knowledgeable in the field of air pollution control to determine that all process equipment including transfer points, air pollution control equipment, storage facilities and loadout procedures are operated and maintained in such a manner to ensure that all dust emissions are controlled to the best extent possible.
6. The Applicant shall ensure that a copy of a report with respect to the investigation undertaken pursuant to Clause No. 5 shall be forwarded to the Director on or before May 1, 1989.
7. The Applicant shall ensure that any equipment installations and upgradings required as outlined in the report prepared pursuant to Clause No. 5, are implemented on or before July, 1, 1989.
8. The Applicant shall not operate any process equipment or air pollution control equipment which is out of repair and discharging abnormal dust emissions to the atmosphere.
9. This Licence replaces Licence No. 1091 which is hereby rescinded.
