**Re: Notice of Alteration – Dangerous Goods Handling and Transportation Act
Licence 91 HW –household hazardous waste collection depot.**

Thank you for your March 26, 2019 Request for Alteration to Dangerous Goods Handling and Transportation Act Licence No. 91 HW located at the City of Brandon, Eastview Landfill. The alteration consists of a request to construct a household hazardous waste building and depot and alter the traffic flow slightly at the entrance of the development.

Upon review of your amendment request, I have concluded that the environmental effects of the proposed changes will be insignificant, and, therefore, you are hereby approved to carry out the proposed alteration to develop a hazardous waste transfer station at the landfill, subject to the following terms and conditions:

1. The Licencee shall not receive at the depot any hazardous waste other than those identified in Schedule A to this letter;
2. The Licencee shall notify the designated Environment Officer upon completion of construction of the new building and shall receive approval in writing for commissioning of the building from the Environment Officer prior to acceptance of any hazardous waste materials at the new building;
3. Environment Act Licence 3149 remains in force;
4. Dangerous Goods Handling and Transportation Act Licence 91 HW remains in force; and
5. Dangerous Goods Handling and Transportation Act Order 1 HWO remains in force.

Due to changes to the Dangerous Goods Handling and Transportation Act in 2018, Licence 3149 will be revised to include conditions from Licence 91 HW and Order 1 HWO into a single licence to be issued to the Development under file 5597.10.

Please be advised that this approval is contingent on the acceptance of a revised Licence that will be issued in the near future. If you have any questions on this matter, please contact Ms. Cory Graham at cory.graham@gov.mb.ca or (204) 250-7645.
