The wood burning contractor has made the following request and I said I would bring forward for your consideration:

Hi Scott,

As discussed, Titan Contractors is requesting a change order to resume the incineration of the wood waste pile in late October/November (weather dependent), Titan has concerns on potential fires caused by embers on the existing wood waste pile and surrounding wood chip piles given we are heading into the summer months. Additionally, this would slow down Titans production given the ash removal process will have to be monitored/saturated with water pumps to control the possibility of floating embers.

Brandon Fire and Emergency Services has expressed the same concerns so any consideration you give for this request is appreciated.
