2012 Renewals

If you have not received your 2012 license and decals, please contact the Taxation Division at (204) 945-5603 or Manitoba Toll-Free at 1-800-782-0318.

Please note that IFTA credentials will **not** be renewed if there are delinquent tax return(s) and/or tax(es) owing under IFTA and/or other tax statutes administered by the Taxation Division. If you do not renew for 2012 by February 29, 2012, your IFTA account will automatically be closed.

Due Date Is....

To avoid penalties and interest, the 4th Quarter 2011 tax return must be filed and any amount due must be paid by **Tuesday, Jan. 31st**.

Faxed Returns

Faxed returns are accepted if the return is NIL, is a credit balance or you have paid the taxes on TAXcess. The faxed return is accepted as the original tax return so please do not mail or drop off a duplicate return!
