UNITIZATION ORDER NO. 2023-01

Pertaining to the Unitized Management, Operation and Further Development of Daly Unit No. 20.

Made and passed pursuant to "The Oil and Gas Act", being Chapter O34 of the Continuing Consolidation of the Statutes of Manitoba, and amendments thereto.

(Filed: August 23, 2023)

WHEREAS, subsection 135(1) of the "The Oil and Gas Act" provides in part as follows:

"135(1) Subject to the approval of the Lieutenant Governor in Council, the minister may make a unit order where the minister is satisfied that, in respect of the proposed unit area, a unit operation.

- (a) will result in more efficient production of oil and gas; or
- (b) is necessary or advisable to prevent waste or to protect correlative rights;

The minister may, with the approval of the Lieutenant Governor in Council, order that the pool, field, or part thereof, be operated as a unit";

AND WHEREAS, the Petroleum Branch has received an application, dated September 5, 2019, from Corex Resources Ltd. as working interest owner of a portion of the Daly Sinclair Lodgepole A Pool requesting that the minister proceed with steps to effect a unitization order for the proposed Daly Unit No. 20;

AND WHEREAS, Corex has submitted as exhibits to the Petroleum Branch, a document entitled "Unit Agreement, Daly Unit No. 20" and documents indicating the consent of 100% of the working interest owner and 97.4% of the royalty interest owners to the said Unit Agreement, Daly Unit No. 20;

NOW, THEREFORE, the minister orders that:

 Effective at the hour of eight o'clock in the morning, official time, on the first day of July, A.D., 2023, a certain part of the Daly Sinclair Field, to be known as the Unit Area, and outlined on Attachment No. 1 to this Order shall be operated as a unit in accordance with the Unit Agreement, Daly Unit No. 20 and shall be known as the Daly Unit No. 20. 2. Attachment No. 1, Exhibits A and B being excerpts from the Unit Agreement, and attached hereto, shall be published in the Manitoba Gazette.

UNIT AREA


