Reporting requirements — person engaged in business

19.1(2) A person who is licensed to provide private investigators or security guards shall report any of the following to the registrar within 15 days after it occurs:

- (a) a change in the person's address for service
- (b) a change in the address of the person's main office or branch office
- (c) a change in ownership or management of the person's business
- (d) a charge laid against the person for a crime
- (e) a conviction against the person for a crime
- (f) a charge laid for a crime or a conviction for a crime against an individual who is employed or engaged by the person as a private investigator or security guard.
