AN ORDER OF THE CLEAN ENVIRONMENT COMMISSION
UNDER THE CLEAN ENVIRONMENT ACT

RE: THE CLEAN ENVIRONMENT COMMISSION and MANITOBA SAUSAGE MANUFACTURING COMPANY LIMITED, Applicant,

WHEREAS pursuant to the provisions of The Clean Environment Act, Manitoba Sausage Manufacturing Company Limited filed an application with the Department of Consumer and Corporate Affairs and Environment in connection with the operation of a plant for the manufacture of cooked and smoked meat products located on Lots 16 to 24, Plan 331, DGS 65, Parish of St. John, at or near 691 Dufferin Avenue in the City of Winnipeg, Manitoba;

AND WHEREAS in the absence of limits, terms and conditions prescribed by a Regulation issued under the said Act, the application was referred to The Clean Environment Commission for the prescribing of limits, terms and conditions;

AND WHEREAS after giving notice of the application, the Commission received notice of representation from persons who are likely to be affected by an order of the Commission issued in connection with the said operation;

AND WHEREAS the Commission held a hearing in Winnipeg, Manitoba, on the 7th day of December, 1981, continuing on the 25th day of January, 1982;

AND WHEREAS a representative of the Applicant testified at the hearing that the incinerator located on the premises of the said plant has been closed down and that all garbage was being removed from the site of the said operation for disposal;

AND WHEREAS the Commission considered the application on the 15th day of March, 1982;

IT IS HEREBY ORDERED THAT

- Assigned to A.P.C. dated 2/6/82*
1. On and after the 1st day of April, 1982, the Applicant shall not permit the emission of solid particulate matter from any point of emission of the said operation to exceed 0.23 grams per standard cubic metre calculated at 25 degrees Celsius and 760 millimetres of mercury.

2. On and after the 1st day of September, 1982, the Applicant shall not cause or permit visible emissions from any point of emission of the said operation that exhibit an opacity equal to or greater than:
 - (a) 20 percent for a period exceeding 4 minutes in any 1 hour at the point of emission;
 - (b) 40 percent at any time at the point of emission.
3. The Applicant shall not, at any time, dispose of garbage or refuse by incineration on the site of the said operation.
4. The Applicant shall ensure that a high standard of equipment maintenance and good housekeeping practices are carried out at all times consistent with meeting the requirements of clauses 1 and 2 of this order.
