Re: Approval for Phase Two Expansion – City of Steinbach Landfill – Environmental Act Licence No. 2918 RR (licence)

Thank you for your email dated June 21, 2022, about the proposed phase two expansion of the Steinbach landfill located on portions of N $\frac{1}{2}$ 23-6-6 EPM. The email sought approval to expand the landfill. It included a June 20, 2022, technical memo with engineering design plans.

The memo meets the requirements of clause 24 of the licence regarding the submission of engineering design plans for approval 30 days before landfill construction begins.

I am satisfied that the potential changes in the environmental effects resulting from the proposed expansion would be insignificant. I approve the expansion following clause 25 of the licence with the following terms and conditions:

- 1. The licensee shall notify the environment officer of the Environmental Approvals Branch no less than five days and no more than ten days before construction begins.
- 2. The licensee shall have all site construction and upgrading activities overseen by an engineer.
- The licensee shall, 30 days after completion of the construction, submit two paper copies and one electronic copy of record drawings of the landfill and all related facilities to the director of the Environmental Approvals Branch at <u>EABdirector@gov.mb.ca</u>.

4. Before setting the new landfill cell into operation or allowing deposition of any solid waste in the new cell, the licensee shall obtain written authorization from the environment officer of the approvals branch.

The City of Steinbach must operate the landfill according to all licence requirements and applicable federal, provincial, and municipal regulations and by-laws.
