A proposal was received on January 5, 2016 from JR Cousin Consultants Ltd. for the continued operation of the Municipal Waste Management Ltd Landfill located on SW 35-08-21 WPM in the Municipality of Souris-Glenwood, Manitoba.

The Proposal was advertised in the Brandon Sun on Saturday February 27, 2016. Copies of the proposal and related documents were placed in the Public Registries at the Millennium Public Library and the Legislative Library. An electronic copy of the proposal and related documents were placed on the Environmental Approvals online registry.
