UPDATES: BOARD AND EXECUTIVE DIRECTOR

1. Chair's Update

The Board Chair provided the following information:

- The Awards of Distinction held on November 3, 2016 was a successful event.
- Apprenticeship Manitoba will be hosting a technical vocational forum in early 2017 to increase knowledge about available programs and the linkages between Manitoba Education and Training, high schools and colleges related to the apprenticeship training and technical vocational education programs.
- He and the Executive Director of Apprenticeship Manitoba met with the Minister of Education and Training.

2. Executive Director's Update

The Executive Director provided the following information:

- The Department of Education and Training has undergone re-organization and further changes are to come.
- Apprenticeship Manitoba is currently undergoing a strategic planning exercise to determine priorities going forward.
- Board member vacancies are still under review.
- The Throne Speech was delivered in November 2016.
- Apprenticeship Manitoba will be a sponsor for the Skills Canada competition being held May 31 to June 3, 2017.
- The Apprenticeship Manitoba website is currently under review and will be updated in spring 2017.

3. Review of previous Board Meeting Evaluation

The Board reviewed the October 19, 2016 meeting evaluation feedback/results and the Board Meeting evaluation 2015-2016 summary. The Board Chair indicated that most of the survey feedback was positive, but some members had indicated that there isn't always sufficient time to discuss agenda items. Ideas or suggestions about how to further improve meeting proceedings may be sent to the Board Coordinator.

1. Nominating Standing Committee (NSC)

The Board reaffirmed the NSC's recommendations to the Welder PAC at its October 19, 2016 meeting.

2. Program Standards Standing Committee (PSSC)

The Board reviewed the PSSC Record of Proceedings.

Gas Turbine Repair Overhaul Technician

The Board reviewed the proposed Gas Turbine Repair Overhaul Technician (GTROT) technical training and trade regulation. The Board approved the PSSC's recommendation to reduce the technical training from two levels to one level. The trade regulation was updated to align with the proposed technical training.

Board members discussed if the proposed technical training/trade regulation will be affected by the New West Partnership Trade Agreement. It was determined that the proposed changes would not be affected by the New West Partnership Trade Agreement as Manitoba is the only province that has designated GTROT.

Technician technical training and trade regulation as written.

De-designation of Crane and Hoist Operator – Power Generation and Transmission

At the October 19, 2016 meeting, the Board directed the PSSC to review the viability of the Crane and Hoist Operator – Power Generation and Transmission (CH-PGT) trade. After a

lengthy discussion, the Board approved-in-principle the de-designation of the CH-PGT trade as it has essentially become an inactive trade.

Motion 2016.12.05 To de-designate the trade of Crane and Hoist Operator – Power Generation and Transmission.

3. Community Liaison Standing Committee (CLC)

4. Governance Standing Committee (GSC)

The Board reviewed the GSC Record of Proceedings.

2017-2018 Board Strategic Plan

The Board has decided to create a 2017-2018 strategic plan that would bridge a transition from the 2014-2017 goals and objectives to the 2018-2021 strategic plan. Consultation on the 2017-2018 strategic plan will take place from December 22, 2016 to January 20, 2017. The GSC will review consultation feedback and provide an updated recommendation to the Board at its next meeting.

Board members noted that some trades listed on the previous strategic plan will be carried over as they are in the process of being harmonized on a national level. The harmonization process can take longer than one year and so may be carried over to subsequent strategic planning years.
