UPDATES: BOARD AND EXECUTIVE DIRECTOR

2.1 Chair's Update

The Chair informed members that:

- AMEC Foster Wheeler and PRISM Economics consultants successfully met the Request for Quote requirement and will administer the Apprenticeship and Certification Board (Board) Governance Review. The consultants will be meeting with stakeholders and staff as part of the review process.
- The Board completed its online consultation survey and consultation sessions throughout the province and gathered valuable input from stakeholders. More than 500 responses to the consultation were received.
- The Chair met with Employment Standards Branch to discuss the Construction Industry Wage (CIWA) and to discuss how CIWA relates to and affects the wages outlined in apprenticeship trade regulations. CIWA was last updated in 2017.
- The Chair and the Executive Director met with the Minister of Education and Training to
 consult with government on the strategic plan and discuss their priorities and expectations.
 The Minister advised he had no specific direction for the Board but did want the plan to
 reflect the government's overall priorities:
 - Transparency
 - Value for money
 - Streamlining Services

- Innovation
- Labour Market Information
- The Plumber Trade compulsory designation request is still in under review.
- The Chair, Executive Director and Apprenticeship staff met with Mechanical Contractors Association of Manitoba.
- There are two current Board member vacancies (one employee position and the one apprentice position). The Minister will appoint individuals into the vacant positions based on applications received through the Agencies, Boards and Commissions.

Construction Electrician

The Board identified the Construction Electrician trade regulation for regulatory review in the 2017-2018 Strategic Plan. The trade regulation was last revised in 2008.

The Provincial Advisory Committee (PAC) reviewed the trade regulation and made minor revisions to the definition section to reflect changes to the 2015 Red Seal Occupational Standard. The PAC conducted a consultation with industry stakeholders from September 05 to September 26, 2017. The consultation did not result in any comments or feedback. The PAC reaffirmed its decision and recommended the proposed trade regulation.

The Board discussed and supported the proposed changes to the regulation.

Industrial Electrician

The trade of Industrial Electrician was identified in the 2017-2018 Strategic Plan for regulatory review. The trade regulation was last updated in 2008.

The Board was informed that the PAC reviewed the trade regulation and made minor revisions to the definition section to reflect the Industrial Electrician 2016 Red Seal Occupational Standard. The PAC conducted consultation with industry stakeholders from October 25 – November 17, 2017. The consultation did not result in any comments or feedback. The PAC reaffirmed its decision and recommended the proposed trade regulation.

The Board discussed and supported the proposed changes to the regulation.

recommendation to approve the Industrial Electrician Trade Regulation

as written.

Power Electrician

The Board identified the trade of Power Electrician in its 2017-2018 Strategic Plan for technical training development.

The Power Electrician PAC changed the associated standard name from Provincial Occupation Analysis to Provincial Occupational Standard (POS) to be consistent with the Red Seal Occupational Standard name.

In addition, the PAC reviewed the POS to ensure common core alignment across the electrical trades and ensure the tasks identified in the occupational standard are current with industry practices.

The PAC conducted industry consultation from June 14, 2017 to July 14, 2017 with the stakeholders who would be affected by any changes in the POS. Seven responses were received, which supported the proposed changes to the POS. The PAC determined to proceed with its recommendation.

The Board discussed and supported the proposed changes to the Power Electrician POS.

Designated Trainer

The Designated Trainer provision was identified for review as part of the 2017-2018 Strategic Plan, as the provision expires on March 01, 2018. The provision was previously reviewed and extended in September 2012.

A Designated Trainer is an experienced, but uncertified, tradesperson who is considered equivalent to a journeyperson for the purpose of apprentice supervision in a voluntary trade. This option is particularly helpful for employers who wish to hire and train apprentices but who do not have a sufficient number of certified journeypersons. It also provides flexibility to employers in rural and northern regions, where there may be a shortage of certified journeypersons. In addition, a significant number of employers use designated trainers to supervise High School Apprenticeship Program apprentices.

During the Board consultation sessions to inform the Strategic Plan, many stakeholders indicated they were in favour of the provision and requested that the provision be extended.

The Board discussed the benefits and impacts of the designated trainer provision and approved-in-principle the extension of the designated trainer provision for five years.

Motion 2017.12.12

The Board accepted the Governance Standing Committee recommendation to extend the Designated Trainer Provision until March 1, 2023.

Board 2018-2021 Strategic Plan Development

The Board completed a Strategic Planning exercise to further refine the objectives for the development of the Strategic Plan for 2018-2023. Next steps will include design and finalization of the plan by Apprenticeship staff and the GS for review and approval at the next Board meeting.
