

### 2. PROGRAM STANDARS

### 2.1 Consultation Results Review

The Sheet Metal Worker consultation was made available to the public from August 02, 2018 to August 24, 2018. One response was received.

The respondent raised concerns that adding an additional unit of Duct System Design to level two, while it is currently only in level three, would amount to having too much Duct System Design content in the program; the respondent felt that one unit of Duct System Design was sufficient for the program.

The respondent also raised concerns regarding the Metal Roofing and Architectural Metal units (in level two) and the Testing, Adjusting and Balancing units (in level three and four). The respondent felt that these unit topics should be covered in context with other units of the program rather than as separate units.

The PAC rationalized:

• That an additional unit of Duct System Design was crucial to the program as the additional training in Duct System Design would provide a stronger foundation in the apprentices training.

• That the Metal Roofing and Architectural Metal unit (in Level 2) and the Testing, Adjusting and Balancing unit (in level three and four) are recommended by the Harmonization Taskforce.

The PAC agreed with the Harmonization recommendation that these units should be in the program. The PAC reached consensus and determined that no changes would be made to the proposed technical training.

#### **Trade Regulation**

The PAC also conducted a regulatory consultation from August 02 to August 24, 2018. The PAC did not receive industry comments/response regarding the regulation. The PAC determined that no regulatory changes were required, except for minor administrative changes at this time.
