## **Reasons For Decision**

- The Appellant, [text deleted], was injured in a motor vehicle accident ('MVA') on December 30<sup>th</sup>, 1996.
- 2. As a result of this MVA, the Appellant experienced severe migraine headaches which her general practitioner, [text deleted], attributed to the MVA. [Appellant's doctor] prescribed Imitrex to assist the Appellant in suppressing her migraine headaches.
- 3. The Appellant was involved in a second MVA on November  $28^{th}$ , 1998.

4. As a result of this second MVA, the Appellant was diagnosed with Post-Traumatic Stress

Disorder and depression. Since the second MVA, she has been prescribed a number of

antidepressants to assist her in overcoming the depression.

5. The Appellant testified that a side effect of her antidepressant medication was severe

headaches. In a letter dated December 5<sup>th</sup>, 2000, her psychiatrist, [text deleted], advised that

the migraine headaches experienced by [the Appellant] are worsened by the antidepressant

medication that she needs to take to assist in her rehabilitation.

6. The Commission finds that the Appellant's need for the medication, Imitrex, is attributable to

both of her motor vehicle accidents and that MPIC should reimburse her for the cost of the

Imitrex.
