Critical Services Worker Survey

At the critical (Red) response level, early learning and child care facilities <u>may</u> be required to provide restricted services (reduced cohorts) with priority given to front-line health care providers and other critical services workers who cannot find alternate child care arrangements.

As child care facilities may not immediately have space to accommodate children of all critical services workers, based on vacancies available and cohort sizes, a prioritization system is needed.

To help determine a prioritization system should one be needed in the future, we are requesting information from families currently enrolled in our facility to confirm the number of children whose parents/guardians are critical services workers.

As part of the direction provided in the province's Pandemic Response System, priority access to vacant spaces must be given to health care providers. Other critical services workers will be eligible and prioritized.

The Department of Families considers the following to be critical services workers:

- 1) Health and health services
- 2) Child care workers (early childhood educators, child care assistants, centre administrators and support staff)
- 3) Kindergarten-to-Grade 12 education providers (teachers, administrators and support staff)
- 4) Law enforcement
- 5) Corrections workers
- 6) Fire and paramedic first responders
- 7) Direct social services and child protection workers
- 8) Other critical service workers, which may include people who provide essential services, such as frontline natural resource workers, essential supply chain staff (e.g., truck drivers delivering food, medications and other essential goods; food industry staff working in food processing plants, etc.), gas station attendants, and grocery store staff.
