**Claims Submission Procedure –  
Vigabatrin (Sabril) 500mg Powder Sachets**

***Effective December 11, 2025***

**Please include this Procedure in your Drug Programs Information Network (DPIN) Manual under Section 4: Claims Submission.**

**\*\*Pharmacies do NOT receive drug interaction information when submitting claims using PINs. Please review all claims carefully prior to submitting\*\***

- There is variable supply of Vigabatrin (Sabril) 500mg Powder Sachets (DIN: 02068036).
- Due to this shortage, Manitoba is outlining the following product selection tree. This selection tree is to encourage pharmacy providers to use existing commercial supply while outlining an alternative option if supply is unavailable:
  - Commercially available product should be dispensed if the pharmacy has inventory on hand or can obtain product through normal distribution channels;
  - The pharmacy vendor may obtain commercially available product from another provider (e.g. another member within the same chain);
  - If commercially available product cannot be obtained, then obtain US-labelled Sabril 500mg Powder Sachets, using the ordering information below.
- There will be limited quantities of US-labelled Sabril 500mg Powder Sachets. As such, these quantities are intended for existing patients who cannot take the 500mg tablet formulation of Canadian-authorized Sabril.
- Orders for US-labelled Sabril can be placed through Accuristix using the following email address: [csrlundbeckLLC@accuristix.com](mailto:csrlundbeckLLC@accuristix.com). When placing an order please provide the following information:
  - Date
  - Customer Name
  - Bill to Name and Address
  - Ship to Name and Address
  - Item # 152203, Sabril Powder for Oral Solution 500mg.
  - Quantity per prescription (# of cartons; 50 sachets per carton). Ensure the total order covers the patient's needs through mid-January. The maximum single order quantity per patient is 6 cartons.
  - Contact information (first and last name, email, phone number)

- The following PIN should be used for the dispensing of US-labelled Sabril 500mg Powder Sachets:
  - PIN 00911971
- The manufacturer will be covering the cost of this product. To enter claims for US-labelled Sabril 500mg Powder Sachets in DPIN:
  - Indicate the quantity as one (1).
  - Indicate the total days' supply you are dispensing.
  - Enter ingredient cost of \$0.00 (if your software does not accept this submission, enter \$0.01 as the drug cost).
  - Enter your usual and customary dispensing fee.
- Manitoba will inform pharmacy providers once the shortage has been resolved and the PIN is no longer required and has been withdrawn for coverage.
