Indigenous and Northern Relations Capital projects update

Dear Mayor and Council:

As Executive Director of the Northern Affairs Branch at the Department of Manitoba Indigenous and Northern Relations (INR), I am pleased to provide this Capital Project Report to present approved infrastructure investments in the Northern Affairs communities for the 2020/21 fiscal year.

This bi-annual report identifies the capital projects approved in the Northern Affairs communities between April 1, 2020 and March 31, 2021. For fiscal year 2020/2021, INR had a \$3.8 million budget for capital projects, referred to as Capital Grants. To maximize this investment, the Department leveraged additional funding that became available, including those from other provincial departments and the federal government. In total, 35 projects were approved and initiated, with \$4.5 million in provincial funding.

The approved community projects this year were determined using a number of criteria including, reviewing previously recommended projects (through the former capital approval board), reviewing of the communities' five year capital plans identified in community management plans, legislated requirements for facility upgrades/replacement, and community requests for critical projects.

INR will continue to use our capital program to provide communities with appropriately designed and well built essential infrastructure that supports health and safety, and social and economic needs. The Northern Affairs Branch is currently reassessing the extensive list of capital projects and reviewing each community's capital plans within the recently submitted Community Management Plans. This evaluation will support project prioritization and selection for the 2021/2022 fiscal year.
