Connecting with Community

Training

The Safety Officer training curriculum is being revised to expand <u>Level 1</u> Induction training to four (4) weeks. Level 1 training will now include Qualified Persons Training under the Mental Health Act.

<u>Level 2</u> training will incorporate operational skill development with 40 hours of 'element specific in field training' which places Safety Officers with police to observe, assist and learn relevant skills, including;

- Road safety & traffic enforcement
- Impaired driving enforcement
- Crisis response skills
- Arrest processing
- Road weight restriction enforcement

Community Safety News

<u>STEINBACH RCMP - STE. ANNE PS – MB Motor Carriers</u>

The Town of Ste. Anne is an 'early adopter' of the Safety Officer Program having created a strong partnership between CSOs and the Ste. Anne Police Service. With a focus on both municipal by-law and Highway Traffic Act, Ste. Anne has improved community and road safety through enactment enforcement and removal of impaired drivers from their roadways.

The City of Steinbach has recently implemented a Transportation and Infrastructure 'protection program' by hiring a Safety Officer (SO) dedicated to Truck Weight monitoring. Steinbach's SO Program works to collaboratively support the RCMP. Manitoba Motor Carrier's Enforcement (MMCE) not only played a key role in training Steinbach's SO but continues to support through radio channel access, equipment loan, expertise, oversight and support.







Ste. Anne PS and Steinbach RCMP have developed a strong inter-agency partnership allowing Ste. Anne SO's to support Steinbach RCMP with Mental Health escort duties, freeing RCMP Officers for core policing duties.



Manitoba's Public Safety Division commends the exemplary teamwork created through effective inter-agency resource sharing which has enhanced efficiency and community safety.

SIOUX VALLEY DAKOTA NATION FNSO PROGRAM & VIRDEN RCMP

Sioux Valley FNSO Justice Coordinator Helena Mazawasicuna has developed a strong working relationship with the Virden RCMP Sergeant Helen Goodman. Virden RCMP have embraced the FNSO Program and are working collaboratively with Sioux Valley by;

- Engaging FNSOs support on major cases to locate witnesses and suspects.
- Connecting FNSOs with Crown Attorneys to prepare reports and witness evidence.
- Teaming up on traffic projects and teaching HTA section numbers and legal authorities.
- Sharing court ordered conditions including warrant status for wanted offenders in community.
- Collaborating on community safety wellbeing issues, problem solving and resource sharing.

Legislation update

The Police Services Amendment Act – Bill 34 - amending The Police Services Act

Bill 34 was presented in the Manitoba Legislature in April and passed 3d reading on May 15th.

Key amendments include;

- The Director of Policing may establish <u>standards</u> respecting police service operations, facilities and equipment
- A police service may provide a specialized policing service and conduct specialized investigation only if it meets the required standards.
- Establish <u>standards</u> for dealing with criminal intelligence



- Expanding the role of Community and First Nation Safety Officers to provide;
 - ✓ An initial response to situations that pose a safety threat before police can attend
 - ✓ Administrative and logistical support to local police in relation to criminal and noncriminal matters
 - ✓ Two or more municipalities may jointly operate a regional community safety officer program.
