

**NOTICE OF PUBLIC HEARING
BY THE MUNICIPAL BOARD OF MANITOBA**

**RE: THE RURAL MUNICIPALITY OF SPRINGFIELD – ZONING BY-LAW NO. 21-25
OBJECTION TO ZONING BY-LAW FROM THE PUBLIC
FILE NO. 26B3-0001**

IN THE MATTER OF: The Rural Municipality of Springfield (the “Municipality”) By-law No. 21-25 (the “Proposed By-law”) amending Zoning By-law 08-01. The Proposed By-law seeks to replace the Municipality’s Zoning By-law No. 08-01.

AND IN THE MATTER OF: Objections from the Public to the Proposed By-law received by the Municipality and referral of the Objections to The Municipal Board (the “Board”) under Section 77(5) of *The Planning Act*.

PUBLIC NOTICE is hereby given that, under the provisions of *The Planning Act*, C.C.S.M. c. P80, and *The Municipal Board Act*, C.C.S.M. c. M240, the Board will hold a public hearing to receive representations from any person on the objections regarding the Proposed By-law.

The public hearing will take place on **Wednesday, May 27, 2026**, and, if needed, on **Thursday, May 28, 2026, and Friday, May 29, 2026** at **9:30 a.m.** at the **Dugald Community Club, 544 Holland Street, Dugald, MB.**

Any interested person may make a representation on the Proposed By-law. A person who wishes to make a written and/or oral presentation to the Board must register by filing a completed Public Presenter Form with the Board at least ten (10) working days prior to the hearing.

The Board requires that an interested person who intends on filing a written submission must file four (4) copies of that material with the Board and one (1) copy with the Rural Municipality of Springfield for public viewing at least ten (10) working days prior to the hearing, failing which copies of the written submission must be provided to the Board and the parties at the hearing.
