CHURCHILL RIVER DIVERSION – SHORT TERM EXTENSION LICENCE REQUEST

We request a five-year Short Term Extension Licence (STEL) for the Churchill River Diversion under the provisions of Section 92 of Water Power Regulation 25/88R.


Manitoba Hydro requested a Renewal Licence on July 26, 2022, and is waiting for further direction from your office on what you require for this Water Power Act renewal process. We understand that your department is working with Indigenous governments to create new environmental assessment guidelines for Manitoba Hydro's legacy water power developments.

Manitoba Hydro submitted technical requirements in 2010 as part of the Final Licence process including project components and Water Power Act licensing requirements. The supporting documentation provided at that time is still valid.

Manitoba Hydro continues to operate Churchill River Diversion in compliance with the Final Licence. This licence is in effect until September 1, 2026. Ongoing compliance with the licence is documented in our Annual Water Levels and Flows Compliance Report.
